1. You and any person(s) for whose benefit you are applying must be 18 years of age or older and must have a Hong Kong address.
2. If you are a firm, the application must be in the individual member's names.
3. The number of joint applicants may not exceed four.
4. If you are a body corporate, the application must be signed by a duly authorised officer, who must state his representative capacity, and stamped with your corporation's chop.
5. You must be outside the United States, not be a United States Person (as defined in Regulation S under the U.S. Securities Act) and not be a legal or natural person of the PRC.
6. Unless permitted by the Listing Rules, you cannot apply for any Public Offer Shares if you are:
 - an existing beneficial owner of shares in the Company and/or any of its subsidiaries;
 - a director or chief executive officer of the Company and/or any of its subsidiaries;

 - an associate (as defined in the Listing Rules) of any of the above; or
 - have been allocated or have applied for or have indicated an interest in any Placing Shares under the Placing.

B. If you are a nominee

You, as a nominee, may make more than one application for the Public Offer Shares by: (i) giving **electronic instructions** to HKSCC via Central Clearing and Settlement System ("CCASS") (if you are a CCASS Participant); or (ii) using a **WHITE** or **YELLOW** Application Form, and lodge more than one application in your own name on behalf of different beneficial owners.

C. Effect of completing and submitting this Application Form

By completing and submitting this Application Form, you (and if you are joint applicants, each of you jointly and severally) for yourself or as an agent or a nominee on behalf of each person for whom you act:

- **undertake** to execute all relevant documents and instruct and authorise the Company and/or the Joint Bookrunners (or their agents or nominees), as agents of the Company, to execute any documents for you and to do on your behalf all things necessary to register any Public Offer Shares allocated to you in your name as required by the Articles of Association;

Determination of Offer Price and Allocation of Public Offer Shares

The Offer Price is expected to be fixed on or about Tuesday, 25 June 2019. Applicants are required to pay the maximum Offer Price of HK\$0.60 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Joint Bookrunners (acting for themselves and on behalf of the Public Offer Underwriters) on or before Tuesday, 25 June 2019, the Share Offer will not proceed.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.

The Company expects to announce the final Offer Price, the indication of the level of interest in the Placing, the level of applications under the Public Offer and the basis of allocation of the Public Offer Shares on Thursday, 4 July 2019 on the website of the Hong Kong Stock Exchange at www.hkexnews.hk and the Company's website at khoongroup.com. Results of allocations in Public Offer, and the Hong Kong Identity Card/passport/Hong Kong business registration numbers (where applicable) of successful applicants will be available on the above websites.

The allocation of Offer Shares between the Public Offer and the Placing is subject to adjustment as detailed in the section headed "Structure and Conditions of the Share Offer – The Public Offer – Reallocation" in the Prospectus. In particular, the Joint Bookrunners (for themselves and on behalf of the Public Offer Underwriters) may reallocate Offer Shares from the Placing to the Public Offer to satisfy valid applications under the Public Offer.
